Thanks to the transparent white glass, the light is emitted in all directions and therefore also lights up the lamp itself. In this way the lighted lamp appears as a floating drop of light, which in itself is very evocative, and at the same time wraps its surroundings in a soft, pleasant light. The Caravaggio Opal pendant is suspended by the three well-known brackets which here form a raw and masculine contrast to the feminine opal glass.
